- The Scorecard Report: Race at Work 2021 will launch, providing members and the public
 with insights into the results of the 2021 Race at Work Survey, and updated
 recommendations to support you to take appropriate action on race at work. This year's
 survey was the biggest yet, with 24,638 responses, and 24,950 of those respondents adding
 valuable additional comments. A huge thanks to all members for your participation in the
 Survey.
- Supporting the report launch, and coinciding with Black History Month, Race Equality
 Director Sandra Kerr CBE will share a blog reflecting on the continued urgent need for
 employers to take concerted action on race at work.
- BITC's Race Equality Team will share briefing papers to help members to meet the latest Commitments of the **Race at Work Charter**.
- A new case study will focus on how global management consultant firm Bain & Co is approaching equal parental leave policies and practice to create a fairer workplace.
 Additional case studies released this month will outline ways in which PwC and McKinsey have been supporting employee wellbeing during times of change and uncertainty, and a case study booklet will present best practice examples of employers supporting colleagues during menopause.
- A new blog, released on World Menopause Day (18 October), will raise awareness of menopause at work, and shine a light on ways in which employers can support people.
